FIELD TRIP SCHEDULE



5-5-90 - HELL HOLLOW, McCONNELL'S MILL STATE PARK Lawrence County, Pa. Leader: Scott Shriver

5-12-90 - QUEBEC RUN WILD AREA, FORBES STATE FOREST Fayette County, Pa. Leader: Scott Shriver

From Uniontown, take U. S. 40 East to the top of Chestnut Ridge. Turn right (south) immediately after Summit Inn onto Seaton Road. (This is also the turn-off for Laurel Caverns.) Go 6.5 miles to a left turn onto Mud Pike Road, an unmarked artery that branches off to the left just as Seaton Road curves sharply right at the 6.5 mile mark. Follow Mud Pike for 1.4 miles. Park in the hard-surfaced parking lot on the right side of the road.

5-26-90 - WOLF CREEK NARROWS (CONSERVANCY SIDE) Butler County, Pa. Leader: Howard McIlvried

From Pittsburgh, take I-79 North to the Slippery Rock Exit. Turn left onto Route 108 and proceed into the town of Slippery Rock. At the light in town, turn left on Route 258. Go one block and turn left on Water Street. Follow Water Street for about 2 miles until it crosses Wolf Creek on an iron bridge. Gross the bridge and park in the small parking area to the left.

Members should expect to see a plethora of late

This should be a new hiking area for most members of the Botanical Society. We will be in a forest setting and can expect to see many varieties of woodland wildflowers.

5-19-90 - RESTHAVEN WILDLIFE REFUGE, CASTALIA Erie County, Ohio Leader: Albert Shriver

Castalia is about 250 miles from Pittsburgh, so allow yourself ample time. Take the Ohio Turnpike to the Sandusky (Route 250) Exit. Then, turn right (north) on Route 250 for 6 miles, left on Route 2 for 6 miles, and left on Route 101 into the town of Castalia. From Castalia take Route 269 northward. The entrance to Resthaven is just a few hundred feet north of the entrance to "The Blue Hole" on the opposite side of the road. Meet in the parking lot near the Resthaven entrance.

The Botanical Society last visited Resthaven in 1985. We expect to see hundreds of the rare <u>Cypripedium</u> <u>candidum</u> (Small White Lady's-Slipper) orchids blooming in a wet marl prairie. Also expected are <u>Smilacina</u> <u>stellata</u> (Star-flowered Solomon's Seal), <u>Potentilla</u> <u>argentea</u> (Silvery Cinquefoil), and <u>Senecio pauperculus</u> (Balsam Ragwort). spring flora including a nice display of <u>Galeris spec-</u> tabilis (Showy Orchis). Other highlight species may include <u>Orobanche uniflora</u> (One-flowered Cancer-root), <u>Hydrastis canadensis</u> (Goldenseal), and <u>Arisaema</u> triphyllum (Jack-in-the-Pulpit).

6-2-90 - POWDERMILL NATURE RESERVE Westmoreland County, Pa. Leader: Bob Lederman

From Pittsburgh, take Route 30 East through Ligonier, then right (south) on Route 381. Proceed on Route 381 to Powdermill and meet at the Nimick Nature Center.

We will explore some of the flora around Powdermill, which should, hopefully, include a nice stand of Spiranthes lucida (Wide-leaved Ladies-tresses).
